I. Call to Order, Reading of Guiding Principles, Introductions

- Tyrie Stanley called the meeting to order at 9:10 a.m. The guiding principles were read and introductions were made.

Consideration and Approval of Proposed Agenda

- The agenda was approved by unanimous consent.
- Carissa Weisdorf indicated that the facilitator of today's meeting, Beth Zemsky, was running late and Carissa will facilitate until she arrives.

Consideration and Approval of August 7 Meeting Minutes

- The minutes were approved by unanimous consent.

II. Brief Review of Council Roles, Vision and Values, and Guiding Values

- Carissa reviewed the Guiding Values for the 2019-2020 Allocations process and presented the ***MCHACP Allocations Retreat PowerPoint***.
- Matt Toburen asked if the Great Minnesota Set Aside is funded by Part B.
 - Colleen Bjerke indicated that it was.

III. Review Conflict of Interest Policy

- Carissa reviewed the council's conflict of interest policy.
 - Matt emphasized that providers are not making money off of the council's allocations and added that the way services are delivered is changing and will not look the same in five years.
 - Roger Ernst clarified that members do not need to leave the room when voting on a slate of services; a conflict only arises when motions are made on specific service areas.

IV. Discussion of Pre-Award Allocations Proposal with a Waiver

Beth Zemsky and Carissa Weisdorf

- Carissa explained that members should use this time for discussion and that motions will be made after the break.
- Jonathan Hanft reviewed the ***Pre-Award Allocations Proposal with a Waiver***.
- Jonathan indicated that Ryan White Part A (Hennepin County) is planning to apply for the Core Medical Services Expenditure Waiver for FY 2019; he hopes it will be in place by the new fiscal year.
- Jonathan noted the following changes made in the allocations proposal from what the council approved last fiscal year:
 - A proposed increase of \$184,500 of Part A funding to housing to fund a pilot program for Ryan White clients who are not virally suppressed and are experiencing housing instability.
 - Jonathan explained that the funding for this would come from emergency financial assistance, insurance premium assistance, food vouchers, and medical transportation. The proposal indicates that funding from Part B would offset these reductions and there will not be reductions to any service area.
 - The housing pilot project would help clients through housing coordination and ongoing housing assistance.
 - Matt asked how long clients would receive this assistance for.
 - Jonathan noted that the HRSA recommendation is to continue housing assistance for two years, though there is nothing that makes it a requirement to stop after two years.
 - Loyal Brooks wondered how many individuals this would help.
 - Jonathan explained that it costs about \$6,000 per year for each client.
 - The pilot project would only be for clients living in the 13 county metro area because it will be funded exclusively by Part A.
 - There are funds currently going to Greater MN for housing from rebate and other sources.
 - Discussion, led by Beth Zemsky:
 - Beth reminded members that housing and childcare were discussed at last week's council meeting for possible allocations proposals.
 - Alejandro Aguilera noted that some service areas not currently funded moved up in the council's prioritization rankings this year. Service areas that were prioritized higher this year include:
 - Childcare
 - Substance Abuse Services- Residential
 - Rehabilitation Services
 - Jonathan explained that there are no unobligated funds in the allocations proposal.
 - John Vener observed that there were not many changes in the prioritization rankings from the previous year's rankings. John noted ambulatory care was ranked lower than in years past.
 - Regarding the housing pilot proposal, Terral Ewing emphasized that the council should make sure that funds are not being used for things that HUD (Department of Housing and Urban Development) might otherwise cover.
 - Terral suggested that the council should be cautious in funding something that would not help many people; he is concerned that this program would not be a long-term solution.

- Tyrie Stanley wondered if any clients have been kicked off housing assistance programs after two years.
 - Jonathan replied that he is not aware of anyone being removed after two years.
 - Jonathan noted that HUD has HOPWA (Housing Opportunities for Persons with AIDS). In addition, other programs include rental subsidies.
 - However, there are long waiting lists for those living with HIV/AIDS in the Twin Cities for these programs.
- Colleen explained that the housing proposal is a pilot program, but there is some evidence that people remain stably housed after two years.
- Gwen Velez was concerned that this will only help 20 people and wondered if the council can affect people more broadly by improving housing literacy.
- Destiny Holiday noted that housing is a major consideration right now and asked how these programs are helping families. Destiny suggested that the council should consider increasing the allocation for housing.
 - Jonathan noted that families could access these services.
- Gelli Overton noted that it would be significant if the housing pilot program helped 20 people find stable housing.
 - Terral agreed that helping one person is great, but he wondered where this discussion landed after the last allocations retreat.
 - Jonathan explained that in 2014, the council added housing as a priority and allocated funds. Prior to that, council did not know if added funds would help.
 - Jonathan noted that housing is an expensive service to fund.
 - The Minnesota Housing Coalition estimates that there are about 1000 people living with HIV/AIDS who are unstably housed.
 - a. There is a reluctance to fund housing because it is so expensive.
 - Ryann Freeman clarified that the housing pilot program would actually help more than 20 individuals.
 - McKinzie Woelfel added that when you help 20 people find stable housing you may also link them to care, which helps with prevention.
 - David Neller suggested that we need to teach clients how to navigate through the system to help people house themselves. The money would go further because it could reach more people.
 - Matt noted that the proposal is building on top of what already exists. This program would target people who are on the verge of falling through the cracks.
 - Lisa Behr wondered if clients receive education about navigating the housing system.
 - Jonathan noted that this would be the role of a housing coordinator, "we want clients to have access to rental assistance, along with ongoing education about housing systems."
- Roger Ernst proposed that the council should explore the idea of creating a pilot program that would alter the requirements of mental health services to make them more broad and accessible.
 - Roger noted that the Mental Health Services Subcommittee found that many clients are not accessing these services.

V. Planning and Allocations Committee Action Item: Pre-Award Allocations Proposal with a waiver

- **MOTION:** Tyrie Stanley moved that the Pre-Award Allocations Proposal with a waiver be approved as submitted to the council by the Planning and Allocations Committee.
 - The Co-chairs requested that Beth Zemsky facilitate the debate of the motion.

- Debate:
 - Childcare:
 - Matt noted that some programs have child care in their operating budgets, but it is not necessarily a line item.
 - Evelyn Combs explained that there are waiting lists for many of the programs that would offer child care support. She noted that most of these programs do not allow for childcare for medical appointments.
 - Lisa explained that there is a two year waitlist for MNFIB (Minnesota Families in Business), but the funds are to be used for work or school, not to cover medical appointments.
 - Val Rubin-Rashaad added that after 3 months on MNFIB, a client could get childcare services.
 - Gwen noted that providing childcare has not always been user friendly; there are many regulations that make it cumbersome to administer.
 - Childcare has not come up as an issue at her agency.
 - Loyal asked why providing childcare is not user-friendly for providers.
 - a. Gwen explained that it is not user friendly because of the obligation to provide evidence that contracts are being followed; her agency does not want to police clients or manage that.
 - Beth noted that what she is hearing is a lot of concern about childcare, but that it is complicated to provide. Beth observed that there is not a lot of evidence being offered about need for childcare.
 - Val noted that there are workgroups at MDH looking into this issue.
 - McKinzie offered to get more information about this.
 - The consensus from the council was to gather more data about the need for childcare before funding it.
 - Mental Health Services:
 - Roger recommended that the Needs Assessment and Evaluation Committee should spend more time on this issue to explore ways to expand access.
 - Ryann noted that there is a workgroup that will be reviewing the standards for mental health services and psychosocial support services.
 - The Planning and Allocation Committee (PAC) has developed a process to conduct a review of standards of care that will be followed for these standards.
 - Jonathan reminded members that may be opportunities to change allocations in the future.
 - Tyrie indicated that PAC sent this proposal forward with no changes.
 - No amendments were introduced.

VI. Presentation of Application Allocations Proposal

Jonathan Hanft, Hennepin County Ryan White Program

Colleen Bjerke, Minnesota Department of Human Services HIV/AIDS Unit

- Jonathan presented the **Application Allocations Proposal**.
- Assumptions made when developing the proposal:
 - There are no changes to Part B funding.
 - A proposed increase of \$184,500 to housing to fund a pilot program for Ryan White clients who are not virally suppressed and are experiencing housing instability.
 - The difference between this proposal and the Pre-Award Allocations Proposal with a Waiver is that medical case management receives \$200,000 more and food bank/home delivered meals receives \$200,000 less in order to meet the 75% core medical requirement.
 - Matt wondered who would not receive food due to this proposed reduction.
 - Jonathan noted that there would need to be reductions in home delivered meals, food shelves, etc.
 - Jonathan added that only the Part A contribution to food bank/home delivered meals would be reduced under this proposal.
 - Food vouchers are available statewide.
 - Greater MN Set Aside receives food vouchers from Part B.
 - Rebate also funds home delivered meals (Mom's Meals).
 - Matt wondered how the council might go about increasing food access in Greater MN.
 - Colleen replied that they would need a needs assessment to determine need.
 - Jonathan noted that we could determine the volume of the need and limitation of the service from the 2015 needs assessment.
 - In 2015, less than 10% of respondents indicated that they need food services, but were unable to access.
 - Terral noted that there have been changes in services for those in Greater MN.
 - Colleen explained that anecdotal evidence indicates that some providers have increased allocations to the service, which indicates a greater need.
 - Colleen added that she is hearing a lot about housing, but not so much about food in Greater MN.
 - Destiny suggested that information about the service is not getting out to the people who need it; "who are we reaching? How are people finding out the available programs?"
 - Destiny, Matt, and Terral indicated that they would be willing to work on a working group to examine this issue further.
 - Jonathan explained that Part A would most likely receive the core medical waiver, so the council will not likely need to implement this plan.

- MOTION:** Tyrie Stanley moved that the Applications Allocations Proposal be approved as submitted to the council by the Planning and Allocations Committee.

- Carissa Weisdorf provided the following updates:
 - There will not be a council meeting in September.
 - The 2nd diversity training will be held at the October 9 council meeting.
- Jeremy Stadelman reminded members to complete the Assessment of the Administrative Mechanism.

IX. Committee Reports

- Executive
 - Action Item:** Carryover Proposal
 - MOTION:** Tyrie Stanley moved that the carryover proposal be approved as submitted to the council.
 - Jonathan noted that there is one correction:
 - Minority AIDS Initiative (MAI) funds (\$9,897) should be included in the carryover amount request. The total carryover request with MAI is \$176,718.
 - Dennis Anderson asked how we know MAI funds are being used correctly if there is money leftover.
 - Jonathan explained that the amount remaining may be due to staff turnover and noted that it is a small amount leftover.
 - Thuan Tran replied that Latinos who receive MAI Outpatient are 98% virally suppressed, so we know that it is an effective program.
 - Destiny indicated that she believes that there is not enough outreach to communities to provide education on services.
 - Destiny suggested that providers need more people of color to provide outreach.
 - Destiny wondered how much diversity there is among agencies and providers.
 - Ryann noted that the council can make service directives about target populations.
 - Rachel Heule noted that Part B MAI is only used to help clients get into services.
 - There was no additional discussion.

 - Carissa noted that the Membership and Training Committee is working to schedule a transgender competency training for the council.
 - Gwen asked if the subcommittee is suggesting that MSM (men who have sex with men) be changed to "cis MSM."
 - Gelli replied yes because it is a way to identify men who were assigned as men at birth who have sex with other men.
 - This would allow transgender data to be available so trends among the community can be identified.
 - Vote: unanimous consent, motion carries.
