Staff for the Minneapolis-St. Paul TGA (MSP-TGA) Part A program includes 5.8 full-time equivalent (FTE) personnel. Staff administer the Part A grant funds including procurement of HIV services and contract administration, support the Minnesota Council for HIV/AIDS Care and Prevention, meet Part A grant conditions of award and reporting requirements, coordinate funding and service delivery with Parts B, C, D and F grantees, manage and analyze client-level data, and manage quality improvement of funded services. No in-house HIV service FTEs are included in the staffing plan since all services are delivered through contractual agreements with subrecipients. The remainder of staff FTEs are funded by county property tax or State of Minnesota 340B ADAP rebate revenue.
