Challenges

- Premium increases from 55-68% for individual health insurance plans
- Narrow networks
- Enrollment caps for insurance plans
 - Medica closing enrollment-Nov 11th
- New Gilead drugs and formulary inclusion
 - Descovy, Odefsey

- Ucare for Seniors Essentials Rx (HMO-POS) (H2459-019)
- Humana plan discontinued for 2017.

- Blue Plus with St. Luke's Gold \$1200 Plan 282
- Blue Plus with Mayo Clinic Gold \$1200 Plan 272
- BlueConnect Gold \$1200 Plan 251
- BluePrint Gold \$1200 Plan 254
- Peak \$1000 w/Copay Gold (for clients living in Stearns and Benton counties)
- No plans available for Crow Wing, Mille Lacs, and Morrison, will have drug benefit only.



Undocumented Key Points

- Open enrollment began November 1 and runs through January 31
 - Applications received by December 15 will have coverage effective January 1
 - Applications received after December 15 and before January 15 will have coverage February 1
 - Applications received between January 15 and January 31 will have coverage March 1



Undocumented Key Points cont.

- Clients must sign application signature page and return to Program HH along with ROI
- Full Name and PMI number needs to be on each page. Sent to clients with info included.
- If clients receive any mailings requesting additional information please alert Program HH ASAP
- Clients will need to seek medical care in 2017 with clinics and hospitals inside their network.

MNSure QHP Key Points

- Open enrollment began November 1 and runs through January 31
- All clients need to go through the MNsure portal
- Assist clients to complete ROI
- Clients must submit invoice to Program HH to establish coverage



APTC (Advanced Premium Tax Credits)

- Clients must enroll in APTC
- Any refund received to client must be given to Program HH if under calculated
- Program HH can assist client with additional payments if over calculated



Additional Points to Remember

- **ESI (Employer Sponsored Insurance) policy change:** Clients that have access to affordable ESI and do not enroll for 2017 will NOT have another plan purchased for them from Program HH, we will keep them on the benefits of the program, including drugs.
- **Program HH application change:** The Health Care Provider form is only needed once for proof of HIV status but not for any subsequent applications. NOTE: The form is still required for clients that have not been enrolled into Program HH before.
